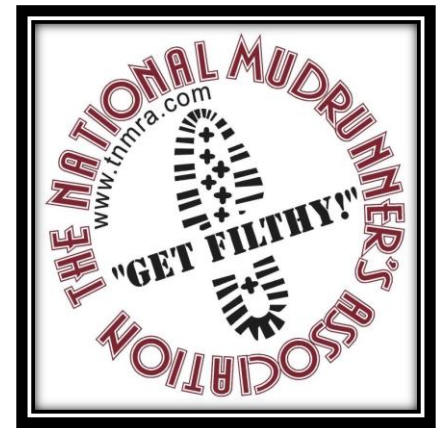




1. I understand that entering The Denton Wild Hog Mud Run (a Denton Calvary Academy/TNMRA's Event) - is a hazardous activity.
2. I understand The Denton Wild Hog Mud Run, TNMRA & Sharkarosa present extreme obstacles including, but not limited to, fire, mud, pits,



steep hills, and ZIPLINE option.

3. **I agree not to participate unless I am medically able.**
4. I agree to not consume alcohol prior to The Denton Wild Hog Mud Run /TNMRA MudRun or ingest any medicines or substance that will inhibit my mental or physical ability to safely and effectively participate.
5. I agree to abide by any decision of the race official relative to my ability to safely compete the race.
6. I agree to obey all civil and criminal laws at all times.
7. I assume all risks associated with competing in The Denton Wild Hog Mud Run /TNMRA MudRun, including falls, injuries, contact with other participants, negligent or acts of other participants, completing all obstacles, defects or condition of premises, the effects of the weather, including high heat /or humidity, all such risks being known and appreciated by me.
8. I agree that The Denton Wild Hog Mud Run, Denton Calvary Academy, TNMRA or Sharkarosa are not responsible for any personal items or property that are lost or stolen in the gear checked area.
9. I consent to emergency medical care and transportation in order to obtain treatment in the event of injury to me as medical professionals may deem appropriate. This release extends to any liability arising out of or in any way connected with the medical treatment and transportation provided in the event of an emergency. The Denton Wild Hog Mud Run, Denton Calvary Academy, TNMRA or Sharkarosa are **NOT RESPONSIBLE**.
10. I understand and will abide by the rule that no wheeled baby conveyances or other wheeled means of conveyance or pets are permitted in the race.
11. I grant permission to The Denton Wild Hog Mud Run, Denton Calvary Academy, TNMRA investments, its affiliates, sponsors, and assigns to use any photographs, motion pictures, recordings, or any other record in this event for any purpose including but not limited to promoting, advertising, and marketing purposes. Any and all photographs, motion pictures, recordings or other records of the event are the sole property of The Denton Wild Hog Mud Run, Denton Calvary Academy, and TNMRA Investments.
12. I understand that all entries are final with no refunds.
13. The official race directors reserve the right in any event of emergency or local or national disaster to cancel the race and in the event of cancellation or change there is no refund of entry fees.
14. Participants are expected to exhibit appropriate behavior at all times, including obeying all laws. This includes respect for all other people, equipment, and facilities.
15. I am at least 18 years of age or my parent/Guardian has reviewed this waiver and consented to its terms.

#### **WAVIER & RELEASE of all claims and assumption of risk**

I recognize and acknowledge that there are certain risks of physical injury to participants in The Denton Wild Hog Mud Run/TNMRA's events, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity. I further agree to waive and relinquish all claims I or my minor child may have (or accrue to

me or my child) as a result of participating in these events against The Denton Wild Hog Mud Run, Denton Calvary Academy, TNMRA or Sharkarosa. Including it's officials, agents, volunteers, sponsors, and employee's.

I do hereby fully release and forever discharge The Denton Wild Hog Mud Run, Denton Calvary Academy, TNMRA and Sharkarosa for any and all claims of injuries, illness, damages, expenses, or loss that my minor/child or I may have or which may accrue to me or my minor/child and arising out of, connected with, or in any way associated with the race, programs or any other activities. I have read a fully understand the above important information, warning of risk, assumption of risk and waiver and release of all claims. When registering online, my online acknowledgement shall substitute for and have the same legal effect as an original form of signature.

PARTICIPATION WILL BE DENIED, if the signature of an adult participant or parent/guardian and date are not signed at the time and place of the race. The Denton Wild Hog Mud Run, Denton Calvary Academy, TNMRA and Sharkarosa are committed to conducting this race and activities in a safe manner and holds the safety of participants in high regards. The Denton Wild Hog Mud Run, Denton Calvary Academy, TNMRA and Sharkarosa continually strives to reduce such risks and insists that all participants follow safety rules and instructions that are designed to protect the participants' safety. However, participants and parents/Guardians of minors registering for the race, programs/activities must recognize that there is an inherent risk of injury when choosing to participate in recreational activities and programs. I am solely responsible for determining if I or my minor child is physically fit and/or skilled for the race or activities contemplated by this agreement. It is always advisable, especially if the participant is pregnant disabled in any way or recently suffered an illness, injury or impairment to consult a physician before undertaking any physical activity. I do hereby fully release and forever discharge The Denton Wild Hog Mud Run, Denton Calvary Academy, TNMRA and Sharkarosa from any and all claims for injuries, damages or loss that my minor child or I may or which may accrue to me or my minor child and arising out of, connection with, or in any way associated with these programs/activities.

I consent to the foregoing and grant permission for him/her to participate in The Denton Hog Wild Mud Run/TNMRA event. I acknowledge I have carefully read, accepted and agreed to the terms on this Release and Liability waiver, and know and understand their contents and I sign the same on my own free act and deed.
